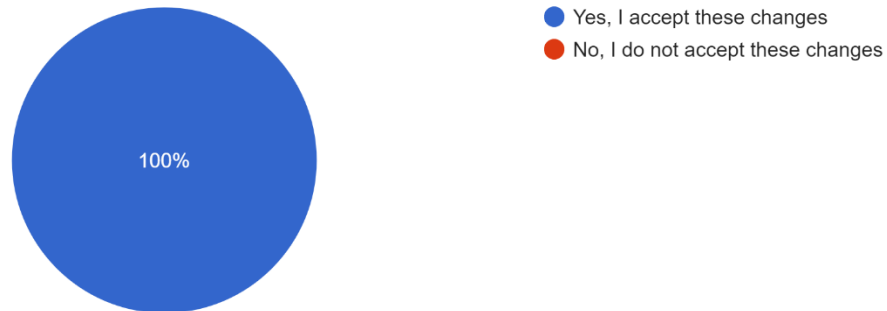


A motion was made to have a MALBUA logo designed to use in all aspects of MALBUA business to include but not limited to clothing, social media, formal documents, web site etc.

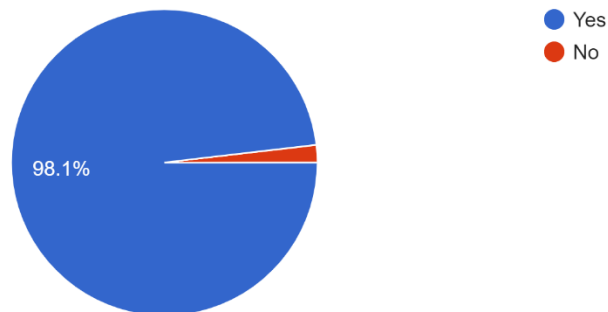
